SSPL shall issue a certificate when the client complies with, all the requirements of NPOP. All certificates issued by SSPL shall remain the property of SSPL and shall be returned when requested. The certificates have validity as stated in the certificate. After the issue of the certificate the client is authorized to use the certification mark/ logo in advertising material and on products in conformity with the following requirements.

General conditions for use of Logo & Certificates

1.0 The client is authorized to use the SSPL's mark or its logo in advertising material and products and while using this mark or logo the client shall ensure that it: -

- (a) Use of SSPL logo/label/reference on any kind of advertising material and products are required prior approval from SSPL
- (b) Conforms to requirements of SSPL when making reference to its certification body's status in communication media such as Internet, brochures or advertising or other documents.
- (c) Does not make or permit any misleading statement regarding SSPL.
- (d) Does not use or permit the use of the certification document or any part thereof in a misleading manner.
- (e) Upon suspension or withdrawal of its certification, discontinues its use of all advertising matter that contains a reference to certification, as directed by conforms to requirements of SSPL.
- (f) Amends all advertising material/product label when the scope of certification has been changed or required by the statutory body.
- (g) Does not imply that SSPL's mark/ logo applies to activities that are outside the scope of its certification.
- (h) Shall not use the SSPL's mark/ logo in such a manner that would bring SSPL and /or the certification system into disrepute and lose public trust.
- (i) SSPL's mark/ logo shall not be applied on visiting cards.

1.1 Whenever the SSPL logo is to be used it shall be proportioned along with other marks, so that neither has obvious precedence or prominence over the other.

1.2 The SSPL's Logo may be uniformly reduced or enlarged and the logo should be legible

1.3. Whenever a subsidiary belonging to a group has been certified there shall not be any confusion as to which part of the group holds the certification and it shall not imply that the other subsidiaries have been certified

2.0 Certification body logo

The SSPL certification mark shall only be reproduced as per the instruction being provided while the permission is awarded for its use.

3.0 Misuse

The misuse of SSPL's marks or certificate shall result in:

Immediate withdrawal of the offending literature by the client or Suspension of approval (certification) until misuse is rectified.

If action is not taken to rectify the misuse within a 10 days, the approval will be withdrawn.

4.0 Withdrawal of certification

In the event that approval is withdrawn, the client shall immediately cease use and distribution of any product, literature, stationary etc bearing the mark. The artwork supplied and all the original approval certificates are to be returned to SSPL.

5.0 Contractual Obligation

5.1 Correct use of SSPL certification is a contractual obligation that the client undertakes to comply with as per agreement signed with SSPL

5.2 Where the SSPL mark have been used by the client, their use is to be reviewed at all surveillance and re-certification audits to ensure that their use is correct and in accordance with the requirements identified in this document.

5.3 Any misuse of logo shall be brought to the attention of the client and included in the surveillance or the re-certification audit reports.

5.4 It is likely that in some cases the client may have to update the logos and they still may have stationery and brochures showing the previously issued SSPL logos. Under such circumstance, it is permissible for the client to continue use of the previously issued logo on the understanding that the new logos must be used in the next printing.
